**RESOLUTION TO AUTHORIZE THE AWARD FOR ENGINEERING SERVICES FOR THE SULLIVAN COUNTY INTERNATIONAL AIRPORT - PARALLEL TAXIWAY REHABILITATION DESIGN.**

**RESOLUTION TO APPROVE ACCEPTANCE OF A NYS DEPARTMENT OF ENVIRONMENTAL CONSERVATION - CLIMATE SMART COMMUNITIES (CSC) GRANT VIA THE CONSOLIDATED FUNDING APPLICATION PROCESS (CFA) AND AUTHORIZE THE LOCAL SHARE OF THE PROJECT FUNDING.**

**WHEREAS**, resolution 274-18 authorized an application for funding to be submitted via the Consolidated Funding Application Process (CFA) for the Hamlet of Kohlertown Flood Risk Reduction Project; and

**WHEREAS**, through the New York State Consolidated Funding Application Process the County has been awarded a Climate Smart Community Grant that provides \$934,084 in State funding towards the estimated \$2,018,170 cost of the Hamlet of Kohlertown Flood Risk Reduction Project; and

**WHEREAS**, \$350,000 of the County's \$1,084,086 local share of cost is anticipated to be funded by \$150,000 from the H19 account budget to acquire property and through \$200,000 of budgeted in-kind engineering services provided by the Division of Public Works staff; and

**WHEREAS**, the amount of \$734,086 will be budgeted for the balance of the local share in future years

**NOW, THEREFORE, BE IT RESOLVED**, that the Sullivan County Legislature hereby authorizes the County Manager, Chairman of the County Legislature, and / or their authorized representative (*as required by the funding source*) to execute any and all necessary documents for the NYS Department of Environmental Conservation - Climate Smart Communities Grant agreement in such form as approved by the County Attorney.

**RESOLUTION TO AUTHORIZE THE APPROVAL OF CONSULTANTS FOR ENGINEERING SERVICE NEEDED FOR LOCALLY ADMINISTERED FEDERAL AID PROJECTS AND OTHER BRIDGE AND HIGHWAY PROJECTS.**

**WHEREAS**, it is a requirement for Locally Administered Federal Aid Project funding, to utilize consultants that are qualified to provide engineering services; and

**WHEREAS**, the Division of Public Works has completed the review of consultant qualifications and has established a recommended list of consultants through the New York State County Highway Superintendents Association, that has followed the procedures required for Locally Administered Federal Aid Projects; and

**WHEREAS**, the firms of: AECOM USA Inc., Latham, NY; Barton & Loguidice D.P.C., Liverpool, NY; C&S Engineers Inc., Syracuse, NY; Delta Engineers, Architects & Land Surveyors, P.C., Endwell, NY and McFarland-Johnson Inc., Binghamton, NY were rated as the top five (5) qualified firms for use by Sullivan County, for bridge and highway projects based upon their qualifications; and

**WHEREAS**, the Division of Public Works recommends the approval of the use of these five (5) firms for Locally Administered Federal Aid Projects and other highway and bridge projects for the three (3) year period of April 1, 2019 thru March 31, 2021.

**NOW, THEREFORE, BE IT RESOLVED**, that the Sullivan County Legislature approves the use of the firms of: AECOM USA Inc., Latham, NY; Barton & Loguidice D.P.C., Liverpool, NY; C&S Engineers Inc., Syracuse, NY; Delta Engineers, Architects & Land Surveyors, P.C., Endwell, NY and McFarland-Johnson Inc., Binghamton, NY for Locally Administered Federal Aid Projects and other highway and bridge projects for the three (3) year period of April 1, 2019 thru March 31, 2021; and
