WHEREAS, the agreement contains a contingency line item; and

WHEREAS, Resolution 431-16 adopted October 20, 2016 defined the Change Order policy for the New Sullivan County Jail Project which provides a maximum limit of \$25,000 for change without a Legislative resolution; and

WHEREAS, the rapid progression of this construction project has led to various changes, some a result of construction coordination and some being owner's requests, which have led to increases and decreases in cost; and

WHEREAS, this change order combines six (6) of these various changes; and

WHEREAS, the cost to the County is \$37,226.58.

NOW, THEREFORE, BE IT RESOLVED, that the County Legislature authorizes the amount of \$37,226.58 from the General Fund to cover the additional cost via a contract change order; and

**RESOLUTION INTRODUCED BY THE PUBLIC WORKS COMMITTEE TO
AUTHORIZE ACCEPTANCE OF AN AIRPORT IMPROVEMENT PROGRAM GRANT
TO REHABILITATE A COUNTY OWNED (5) BAY HANGAR AT THE SULLIVAN
COUNTY INTERNATIONAL AIRPORT (SCIA)**

WHEREAS, The NYSDOT Airport Improvement and Revitalization Program has offered a grant to Rehabilitate a five (5) bay hangar at the SCIA; and

WHEREAS, Sullivan County desires to rehabilitate said five (5) Bay Hangar; and

WHEREAS, an Airport Improvement Program Grant is available in the amount of \$421,000 where the 90% State share is \$378,900 and the 10% local share would be \$42,100.

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature authorizes the County Manager to sign any and all necessary agreements, contracts and documentation, in such form as the County Attorney shall approve, to accept a NYSDOT Airport Improvement Program grant amount not to exceed 90% State share at \$378,900 and local share at \$42,100 and this authorization is contingent on final approval of said grants; and

BE IT FURTHER RESOLVED, that the County Manager or the Chairman of the County Legislature (as appropriate based on the requirements of funding source or as required by law), be and hereby is authorized to execute any and all agreements, certifications or other documents, each in such form as shall be approved by the Office of the County Attorney, necessary to administer the grant, including advancing funds and/or disbursing funds to grant recipients; and
