RESOLUTION OF THE EXECUTIVE COMMITTEE ACCEPTING THE RECOMMENDATIONS OF THE SULLIVAN COUNTY SOLID WASTE/RECYCLING FEE GRIEVANCE COMMITTEE

WHEREAS, the Sullivan County Legislature (“Legislature”) Amended Local Law No. 7 of 2009 to add Article VIII to said Local Law Establishing a Solid Waste Recycling Fee, and

WHEREAS, Local Law No. 7 of 2009 as amended provides for a Sullivan County Solid Waste/Recycling Fee Appeals Committee (“Committee”) to review written appeals from property owners, and

WHEREAS, the Committee wishes to report its recommendations to the Legislature, and

WHEREAS, the Committee has reviewed the appeal of Evelyn Hefter, the owner of parcel designated as DE7.-5-14 and it recommends approving the reduction of the user fee reflected on the 2018 County/Town tax bill for said parcel due to the fact that the parcel was incorrectly charged a commercial user fee of \$300.00 when in fact the parcel should have been charged a residential user fee of \$120.00.

NOW, THEREFORE, BE IT RESOLVED, that the Legislature acknowledges receipt of the Committee’s recommendation mentioned above and hereby ratifies said recommendation of the Committee.

BE IT FURTHER RESOLVED, that the Legislature hereby authorizes the Sullivan County Treasurer, on behalf of the Committee to notify the property owner regarding approval of her appeal.
