AUTHORIZE AWARD AND EXECUTE CONTRACT TO MILLENNIUM HEALTH FOR TOXICOLOGY SERVICES FOR SULLIVAN COUNTY DEPARTMENT OF COMMUNITY SERVICES

WHEREAS, toxicology testing services are required for the Department of Community Services to monitor clients for illicit substance use and to monitor prescribed medications are taken accordingly; and

WHEREAS, the New York State Office of Alcohol and Substance Abuse Services (OASAS) requires the Department of Community Services to provide toxicology testing services under Regulation #822.7 G 5; and

WHEREAS, Millennium Health, 360 Third Avenue, Troy, NY 12182 will be providing the laboratory testing for the toxicology's to monitor clients' for illicit substance abuse and to monitor prescribed medications are taken accordingly; and

WHEREAS, Millennium Health will directly bill clients and their insurance companies to cover the costs of said testing; and

WHEREAS, Millennium Health will comply with all HIPAA guidelines; and

WHEREAS, Millennium Health shall provide toxicology testing services to clients' for illicit substance abuse and to monitor prescribed medications are taken accordingly. This agreement shall be renewed automatically on an annual basis subject to termination by either party upon thirty (30) days prior written notice and shall be effective May 1, 2018.

NOW, THEREFORE, BE IT RESOLVED, the County Manager be and hereby is authorized to execute a contract, with Millennium Health, and said contract be in such form as the County Attorney shall approve.
